RE: Formal Comment on the Work of the Anticompetitive Regulations Task Force

Assistant Attorney General Slater:

We respectfully submit this formal comment in strong support of the Anticompetitive Regulations Task Force and its mission to identify and eliminate unnecessary laws and regulations that burden American consumers, workers, and businesses.

This initiative, launched under the direction of President Trump and the Antitrust Division, is a vital step toward restoring a competitive economic landscape that fosters innovation, supports entrepreneurship, and protects the rights of consumers. The Executive Orders recently signed by President Trump—Executive Order 14192 and Executive Order 14219—make clear the Administration's commitment to reducing regulatory burdens and enabling all Americans to benefit from a dynamic, competitive marketplace.

As the Task Force carries out its work, we urge consideration of the successful conservative regulatory models implemented by Elected Republican Public Utility Commissioners across the country.
